

Terms and Conditions

Delivery Terms

UK orders will be sent via Courier Service with a 3-7 day delivery. This standard delivery service is at a cost of £8.99 each unit.. Orders are dispatched Monday-Friday. Assuming an item is available and in stock, orders must be placed before 2pm to qualify for next day processing. Orders placed after this time will be processed the next working day. Any Orders placed after 2pm will be processed the next working day. If an order is placed after 2pm on a Friday or over the weekend they will be processed on the following Monday. Items out of stock will be subject to longer delivery times and we will liaise with you personally to inform you in this case of an anticipated delivery time. You will have the option of changing or cancelling an order if you are not happy with an anticipated proposed delivery time. A signature is required at the point of delivery. Should there be no one to accept delivery the parcel will be sent back to your local depot and you will be left a card detailing how to arrange re-delivery or local pick up. If the courier does not hear from you for around 5 days after a card has been left they will return the package to us. Should you then require the parcel to be redelivered the delivery charge will be incurred.

Ordering/Returns

We reserve the right to refuse or cancel any order once it has been placed if, for example: Your payment has been marked as fraudulent or potentially fraudulent by the payment system. Payment has been made using a card not issued in a country we dispatch to. If the items you have ordered are unavailable you will be notified as soon as possible. In order to adapt to customer feedback we reserve the right to amend and improve product specifications. We may from time to time send newsletters to our customers whenever we have news to tell. Should you prefer not to receive our mail you are free to unsubscribe at any time. We respect your confidentiality and we will never make your details available to any third party.

Full Terms and Conditions

Background

- This agreement applies as between you, the User of this Website and Soladapt Ltd , the owner of this Website. Your agreement to comply with and be bound by these Terms and Conditions is deemed to occur upon your first use of the Website. If you do not agree to be bound by these Terms and Conditions, you should stop using the Website immediately.
- No part of this Website is intended to constitute a contractual offer capable of acceptance. Your order constitutes a contractual offer and our acceptance of that offer is deemed to occur upon our sending a dispatch email to you indicating that your order has been fulfilled and is on its way to you.

Definitions and Interpretation

In this Agreement the following terms shall have the following meanings:

“Account”

means collectively the personal information, Payment Information and credentials used by Users to access Paid Content and / or any communications System on the Website;

“Carrier”

means any third party responsible for transporting purchased Goods from our Premises to customers;

Returns Policy

- If you receive Goods which do not match those that you ordered, unless accompanied by an explanatory note detailing the changes, stating reasons for the changes and setting out your options, you should contact us within 10 days to arrange collection and return.
- Soladapt Ltd will refund shipment costs, should the Company to be found responsible. You will be given the option to have the Goods replaced with those ordered (if available) or to be refunded through the payment method used by you when purchasing the Goods. Refunds and replacements will be issued upon our receipt of the returned Goods.
- If any Goods you have purchased have faults when they are delivered to you, you should contact Soladapt Ltd within 28 days to arrange collection and return.
- Soladapt Ltd will refund shipment costs once the product has been received and a manufacture fault diagnosed. Goods must be returned in their original condition with all packaging and documentation. Upon receipt of the returned Goods, the price of the Goods, as paid by you, will be refunded to you through the payment method used by you when purchasing the Goods.
- If any Goods develop faults within their warranty period, you are entitled to a repair or replacement under the terms of that warranty.
